ALL VENDORS PLEASE READ THESE NOTES BEFORE SUBMITTING ENTRIES

- A separate herd health declaration form must be submitted by each Vendor.
- A maximum of two bull entries may be made per Vendor (excluding calves at foot).
- An upset price of £1000 for females over 12 months and £1500 for males over 12 months will be in operation at this sale.
- Any female sold for breeding (excluding calves at foot) must be sire verified. Bulls (excluding calves at foot) must be sire verified and Hypotrichosis tested. All animals being sold as in-calf must have a positive PD from a licensed Veterinarian. No warranty as to the animal being in-calf following the point of sale is given. The Vendor warrants that any bull sold (excluding bull calves at foot) is fertile and capable of natural service up to 16 weeks following the point of sale.
- Cows with calves at foot will be considered one lot, otherwise all animals must be sold as individuals.
- All entries requiring a TB test must be tested within 28 days prior to the end of the sale.
- Any lots sold privately within 35 days of the sale must be booked through the Auctioneers and the relevant commission paid.
- All animals will remain the responsibility of the Vendor until collection of the animal by the Buyer.
- All entries (excluding calves at foot) from UK Vendors must be fully registered in the Traditional section of the Hereford Cattle Society Herdbook denoted by [*] following the name. Entries from overseas Vendors are also most welcome, although different registration rules may apply at the time of sale – please contact sale organisers to discuss.
